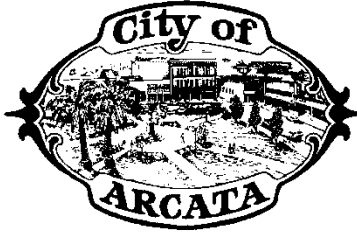

RE: DISPATCHER/SENIOR DISPATCHER RECRUTMENT – REQUIRED TESTING

Dear Candidate:

Thank you for your interest in the position of Dispatcher/Senior Dispatcher for the City of Arcata. You are invited to test for this position on **Thursday, July 10th, 2014**. The examination will be administered beginning at **9:00 a.m. at the D Street Neighborhood Center, 1301 D Street, Arcata** (see map on reverse). You will need to allow approximately 3 1/2 hours for this examination.

Report, no earlier than ten (10) minutes before the scheduled examination time, to the main entrance of the building. Signs will be posted. Please wait outside these doors until called into the testing room. Once called inside, you will be required to show your picture I.D. Late candidates will not be admitted to the testing, and parking passes will be available at the door upon request.

To confirm your test attendance, complete question #4 of the supplemental application and return the completed application packet as soon as possible to secure a test space. Test reservations are on a first come basis, and limited to the first 30 applications received. If you are not part of the first 30 applicants, but wish to test, you will be on a stand-by basis the morning of the test if any cancellations occur. Standbys will be granted to those present the morning of the test, and in the order of which applications were received.

The examination being administered is a Peace Officer Standards & Training (POST) entry-level public dispatcher test. This examination is designed to measure abilities that are both essential for successful performance of dispatcher duties and necessary for candidates to possess before hire. These abilities fall into four primary areas: verbal ability, reasoning ability, memory ability and perceptual ability. Applicants may view an Examinee Guide at www.post.ca.gov. On the Home page, select the "Hiring" tab at the top of the page; scroll down to select "Dispatchers"; then select "Overview of Public Safety Dispatcher Selection Standards". Under the sub-heading "Written Examination", select "POST Entry-Level Dispatcher Selection Test Battery: Examinee Guide 1996" (second paragraph).

NOTE: *If you have taken the POST Entry Level Dispatcher examination within the last twelve (12) months, you may submit written documentation, on official letterhead, that verifies the agency in which you tested, the date you tested, and your T-Score. You must have a T-Score of at least 55 to be placed on the eligibility list; otherwise, you will need to attend the City of Arcata testing on July 10, 2014 to be included in the next group of candidates. **IMPORTANT: POST does not allow applicants to take this test more than once within a 30 day period. If this is the case when you test with us, POST will reject the test when it is submitted for scoring.***

Applicants will receive written test results within two weeks of testing. No results will be given out in person or over the phone. All candidates receiving a passing score will be placed on an eligibility list. The top 3 candidates will be the first to continue to the next phase of the selection process, which includes a Police Chief's interview, an extensive background investigation, Voice Stress Analyzer, psychological evaluation, and a complete physical examination. The eligibility list is valid for at least one year. If the current position is not filled from the initial three candidates on the list, additional names from the eligibility list will be forwarded to the department until the vacancy (cies) is/are filled.

APPLICATIONS SUBMITTED AFTER JULY 10, 2014 (or after the first 30 received):

Should an appointment not be made from the eligibility list established from the July 10, 2014 test date, the City of Arcata may decide to conduct additional testing with applications submitted after July 10, 2014 (or after the first 30). If an additional examination is scheduled or the recruitment is closed, you will be notified.

Applications for this position are currently being accepted on an ongoing basis. Please refer to the City website or contact this office for any possible future test dates offered by the City.

Again, to confirm your attendance for the July 10th, 2014 examination, complete question #4 of the supplemental application and return the completed packet as soon as possible to secure a test slot.

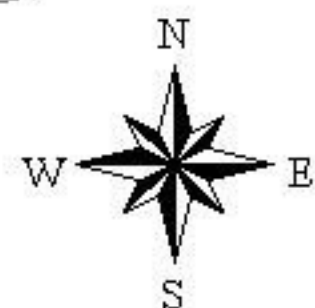

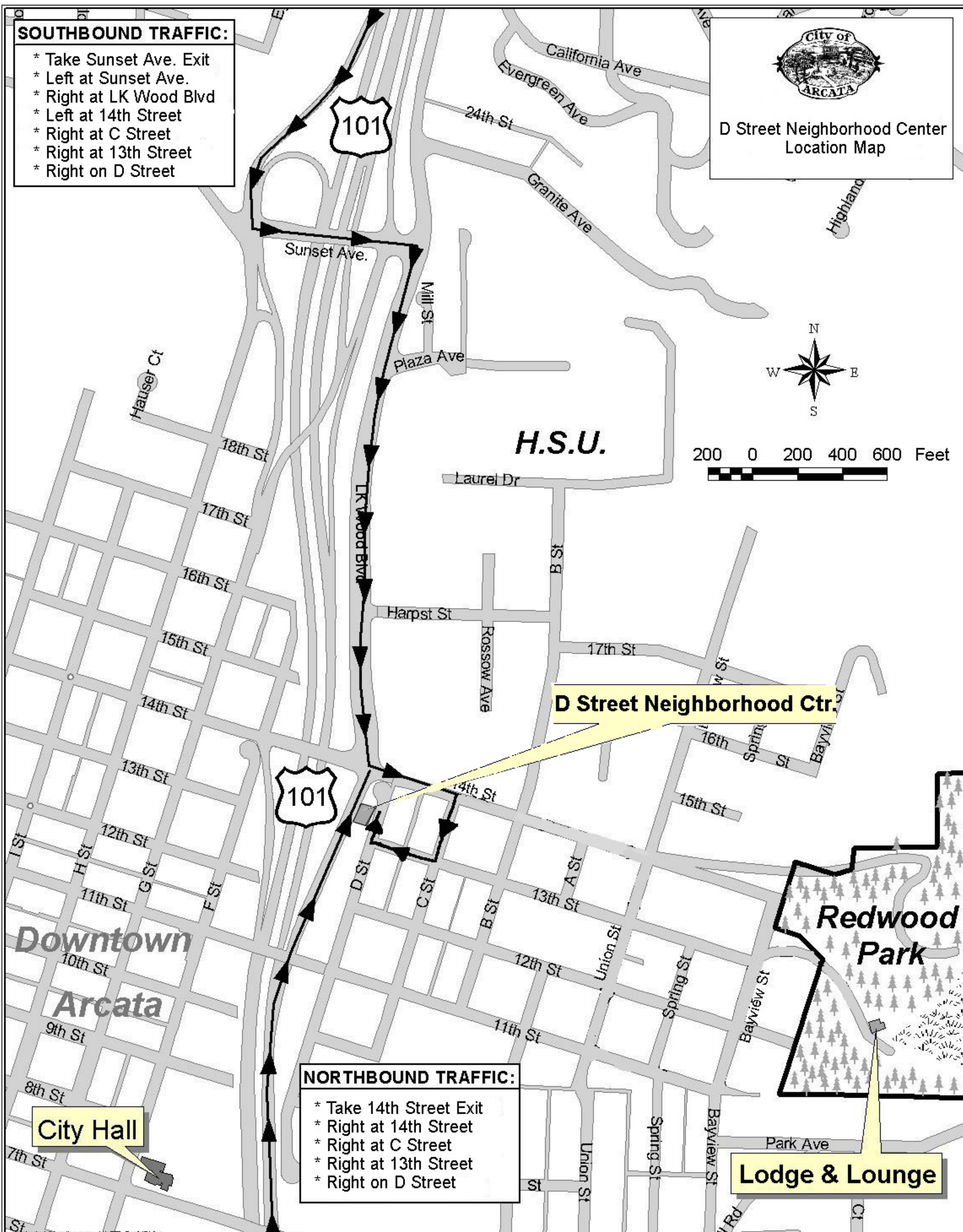
