A. **Continued Projects.**

1. **Campbell Creek Apartments, File Number 090-004-PDP-CDP-DR2, Assessor Parcel Number 503-202-003.**

The Campbell Creek Apartments Planned Development project involves the proposed development of a 4.02-acre vacant parcel located on the corner of Samoa Boulevard and Union Street with 60 residential units and 2.94 acres of open space that includes restored wetland and buffer areas, a wildlife corridor and connecting trail system. The project was approved by the Planning Commission on February 22, 2011.

B. **New Projects.**

1. **Foodworks Master Sign Plan, 100 Ericson Court, File Number 101-121-DR.**
Project proposes a Master Sign Plan for the Foodworks Culinary Center, located in the Aldergrove Industrial Park. Proposed signage totaling about 117.5 square feet includes: one 28 sf monument sign; one 30 sf directory sign; one 4 sf hanging sign placed under the building's front entrance canopy; one 18 sf wall sign on the east building elevation; and 25 door signs for individual tenant spaces (total area 37.5 sf).


