

RESOLUTION NO. 190-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ARCATA ADOPTING OF THE ANNUAL BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2019

WHEREAS, the proposed budget for the City of Arcata for the fiscal year beginning July 1, 2019, as presented by the City Manager, has been reviewed, studied, and revised by the City Council;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Arcata as follows:

Section 1: That the budget document entitled "City of Arcata Fiscal Year 2019/20 Annual Budget" as presented by the City Manager at a scheduled Council meetings on May 15 and June 5, 2019 is adopted as the budget of the City for the 2019/20 fiscal year, including all budget and fiscal policies outlined therein, and the amounts stated therein as proposed expenditures for the purpose therein stated shall be and are hereby appropriated to the several objects and purposes therein stated. The total appropriations are summarized as follows:

Section 2: That, as required by the Revenue and Taxation Code Section 7910, the appropriations limit for the fiscal year 2018/19 is \$14,896,248 and the appropriations limit for the fiscal year 2019/20 is \$15,269,012. Also, that neither the appropriations for the 2017/18 or 2018/19 fiscal years, which are subject to the appropriations limit as set forth in Article XIIB of the California Constitution, exceed their respective limits as stated above. Also, that the annual adjustment factors that were selected to calculate the 2019/20 limit were: 1. California Per Capita Personal Income; and 2. City of Arcata Population Growth.

Section 3: General Fund reserves are anticipated to increase by \$14,843.

Section 4: Modifications and amendments to the 2019/20 City of Arcata Budget shall be allowed during the 2019/20 fiscal year, when in conformance with the "Budget and Fiscal Policies".

Section 5: This resolution is effective July 1, 2019.
