The data is correct in the report and in the FINAL Submittal 2020 UWMP Tables 04.02.2021 Excel file, so we are not quite sure where the data error came from. The one clue we have is that the PWSID for City of Arcata is listed at 1210021. The PWSID for the City of Arcata is 1210001. Again, we are unable to locate where the PWSID has been entered incorrectly. Is it possible to give us some ideas on where to focus our search for the error or how to fix the incorrect PWSID for the City of Arcata?
