The Wetlands and Creeks Committee was established in 1992. The Committee serves in an advisory capacity to the City Council, City Manager and City staff in matters related to policies, management and projects affecting creeks, wetland and tideland resources in Arcata.

The Committee is to have regularly scheduled meetings every month, on the third Tuesday of the month. Its seven members, appointed by the City Council, serve overlapping three-year terms and represent various areas of expertise, knowledge/interest.

The Committee had its regular meetings during the past year, as well as study sessions and subcommittee meetings.

A. Creek and Wetlands/ Policies/Ordinances

The Committee reviewed and made recommendations of the following items:

1. The Committee made additional recommendations on the draft *Land Use Code* (LUC). The sections reviewed by the Committee were:
9.59-Environmental Sensitive Habitat Areas Protection and Preservation;
9.66-Urban Runoff Pollution Control
9.64-Grading, Erosion and Sediment Control
9.34-Landscaping Standards. Comments were related to ESHA impacts, stormwater impacts, xeriscaping, native plants, no invasives, no pesticides.
9.42.190-Windmills. Need for biological assessment for impacts to ESHA's

5. Stormwater management and water quality — promoting good design – LID, promoting infiltration over detention basins, ongoing education for residents and various business sectors
6. Continue to assist with Stormwater Management Program and Master Plan Implementation
7. Assist Open Space Committee regarding recommendations of open space funding mechanisms
8. Review and comment on County General Plan update as it applies to City of Arcata planning area and wetlands/creek resources
9. Review and comment on the Parks and Recreation Master Plan updates
