What is SB 1383?

SB 1383 is a California state mandate that aims to reduce organic waste destined for landfills by 75%, and to recover 20% of edible food that would otherwise be sent to landfills by 2025.

Why is this law in place?

Food waste is the second largest contributor of organic matter in California landfills, which produces methane gas, a known greenhouse gas pollutant. California has made a commitment to reduce greenhouse gas emissions and air pollution by implementing SB 1383.

How and when does this affect my business?

As a Tier 1 or Tier 2 food generator (see table below), your location must comply with SB 1383 or face possible fines and penalties.

*Applicable to each location where food waste is generated.



SB 1383 Timeline of Requirements

Year	Requirements	Required Actions
January 1 2022	Regulations take effect and enforcement begins	Comply with record keeping and reporting for Tier 1 donors
January 1 2024	Local governments take over enforcement	Tier 2 operators must be compliant with SB 1383 requirements

How does my location become compliant?

Step 1:



Secure written agreements or contracts with food recovery organizations that receive your donation.

Step 2:



Begin donating excess edible food.



Maintain donation records at business location to be submitted to your city.
