 - 1. Arcata Bay Crossing, 250 "E" Street, File Number 101-087.

The Arcata Bay Crossing project proposes development of a transitional housing facility located at 250 "E" Street, Arcata. Project proposes construction of a two-story, 10,000 square foot building that would provide up to 40 beds for the facility. This is the second of two HDRC project reviews to consider site layout, circulation and parking, building design, green building, landscaping, solid waste/recycling and outdoor lighting.

1. Storage Shed, 1260 Spring Street, File Number 101-103.

Project proposes construction of a detached storage shed within the front setback area of a single family residential property located in the Bayview Neighborhood Conservation Area. An approximately 93.5 square foot, 12-foot high shed would be sited behind existing parking spaces, with stairs connecting from the shed and parking area to the front entrance of the residence.
