

## **ORDINANCE NO. 1409**

### **AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ARCATA AMENDING THE ARCATA MUNICIPAL CODE, TITLE VIII—BUILDING REGULATIONS, CHAPTER 1—BUILDING CODES, ARTICLES 1–14, PERTAINING TO UNIFORM BUILDING REGULATIONS**

The City Council of the City of Arcata does ordain as follows:

Section 1: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 1—Part 2 California Building Code, Section 8000, of the Arcata Municipal Code is hereby amended as follows:

#### **ARTICLE 1—PART 2 CALIFORNIA BUILDING CODE**

##### **SEC. 8000. Adoption.**

The provisions of the California Building Code, 2010 Edition, California Code of Regulations Title 24, Part 2, Volumes 1 & 2 including, Appendix B (Board of Appeals), Appendix H (Signs), Appendix I (Patio Covers) and Appendix J (Grading), as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 2: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 2—Part 1 California Administrative Code, Section 8010, of the Arcata Municipal Code is hereby amended as follows:

#### **ARTICLE 2—PART 1 CALIFORNIA ADMINISTRATIVE CODE**

##### **SEC. 8010. Adoption.**

The provisions of the California Administrative Code, Title 24, Part 1, 2010 Edition, as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 3: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 3—Part 3 California Electrical Code, Section 8030, of the Arcata Municipal Code is hereby amended as follows:

## **ARTICLE 3—PART 3 CALIFORNIA ELECTRICAL CODE**

### **SEC. 8030. Adoption.**

The provisions of the California Electrical Code, Title 24, Part 3, 2010 Edition, based on the 2008 Edition National Electric Code, as published by the National Fire Protection Association with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the National Fire Protection Association with California amendments are hereby adopted and the Code is adopted as a whole.

Section 4: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 4—Part 4 California Mechanical Code, Section 8040, of the Arcata Municipal Code is hereby amended as follows:

## **ARTICLE 4—PART 4 CALIFORNIA MECHANICAL CODE**

### **SEC. 8040. Adoption.**

The provisions of the California Mechanical Code, Title 24, Part 4, 2010 Edition, based on the 2009 Uniform Mechanical Code, as published by the International Association of Plumbing and Mechanical Officials with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 5: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 5—Part 5 California Plumbing Code, Section 8050, of the Arcata Municipal Code, is hereby amended as follows:

## **ARTICLE 5—PART 5 CALIFORNIA PLUMBING CODE**

### **SEC. 8050. Adoption.**

The provisions of the California Plumbing Code, Title 24, Part 5, 2010 Edition, based on the 2009 Uniform Plumbing Code, as published by the International Association of Plumbing and Mechanical Officials with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 6: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 6—Uniform Solar Energy Code, Sections 8060–8062, of the Arcata Municipal Code is hereby repealed.

Section 7: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 6—Part 2.5 California Residential Standards Code, Sections 8060–8062, of the Arcata Municipal Code is

hereby added to the Arcata Municipal Code as follows:

## **ARTICLE 6—PART 2.5 CALIFORNIA RESIDENTIAL STANDARDS CODE**

### **SEC. 8060. Adoption.**

The provisions of the California Residential Code, 2010 Edition, California Code of Regulations Title 24, Part 2.5, including, Appendix G (Swimming Pools, Spas and Hot Tubs), Appendix H (Patio Covers), Appendix J (Existing Buildings and Structures), as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

### **SEC. 8061. Deposit of Copies.**

One copy of said code shall be filed for use and examination by the public in the office of the Building Official. The same or identical copy thereof shall at all times be kept on file for similar use.

### **SEC. 8062. Violations.**

Violation of any provision of said code is declared to be an infraction punishable by all sanctions prescribed in Title I of the Arcata Municipal Code for violations of the Arcata Municipal Code.

Section 8: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 8—International Existing Building Code, Sections 8100–8102, of the Arcata Municipal Code is hereby repealed.

Section 9: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 8—California Green Building Standards Code, Sections 8100–8102, of the Arcata Municipal Code California Green Building Standards Code is hereby added to the Arcata Municipal Code as follows:

## **ARTICLE 8—PART 11 CALIFORNIA GREEN BUILDING STANDARDS CODE**

### **SEC. 8100. Adoption.**

The provisions of the California Green Building Standards Code, Title 24, Part 11, 2010 Edition, as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with

California amendments are hereby adopted and the Code is adopted as a whole.

**SEC. 8101. Deposit of Copies.**

One copy of said code shall be filed for use and examination by the public in the office of the Building Official. The same or identical copy thereof shall at all times be kept on file for similar use.

**SEC. 8102. Violations.**

Violation of any provision of said code is declared to be an infraction punishable by all sanctions prescribed in Title I of the Arcata Municipal Code for violations of the Arcata Municipal Code.

Section 10: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 9—Part 12 California Referenced Standards Code, Section 8110, of the Arcata Municipal Code is hereby amended as follows:

**ARTICLE 9—PART 12 CALIFORNIA REFERENCED STANDARDS CODE**

**SEC. 8110. Adoption**

The provisions of the California Referenced Standards Code, 2010 Edition, as published by the California Building Standards Commission, are hereby adopted and the Code is adopted as a whole.

Section 11: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 11—Part 10 California Existing Building Code, Section 8130, of the Arcata Municipal Code is hereby amended as follows:

**ARTICLE 11—PART 10 CALIFORNIA EXISTING BUILDING CODE**

**SEC. 8130. Adoption.**

The provisions of the California Existing Building Code, 2010 Edition, as published by the International Code Council and all revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council are hereby adopted and the Code is adopted as a whole.

Section 12: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 12—Uniform Swimming Pool, Spa and Hot Tub Code, Sections 8140–8142, of the Arcata Municipal Code, is hereby repealed and this Article is reserved.

Section 13: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 13—Part 8 California Historical Building Code, Section 8150, of the Arcata Municipal Code is hereby amended as follows:

## **ARTICLE 13—PART 8 CALIFORNIA HISTORICAL BUILDING CODE**

### **SEC. 8150. Adoption.**

The provisions of the California Historical Building Code, Title 24, Part 8, 2010 Edition, as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 14: Title VIII—Building Regulations, Chapter 1—Building Codes, Article 14—Part 6 California Energy Code, Section 8160, of the Arcata Municipal Code is hereby amended as follows:

## **ARTICLE 14—PART 6 CALIFORNIA ENERGY CODE**

### **SEC. 8160. Adoption.**

The provisions of the California Energy Code, 2010 Edition, as published by the International Code Council with California amendments, and all other revisions, supplements and amendments heretofore and hereafter adopted by the International Code Council with California amendments are hereby adopted and the Code is adopted as a whole.

Section 15: Severability. If any section, subsection, sentence, clause or phrase of this chapter is for any reason held to be invalid or unconstitutional, the decision shall not affect the validity of the remaining portions of the Chapter. The City Council hereby declares that it would have passed this Chapter, and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid under law.

Section 16: This ordinance will take effect thirty (30) days after the date of its adoption.
