## Introduction

As a hands-on field project, the following reconnaissance survey was completed as a learning tool to practice lessons on neighborhood surveys and research/documentation techniques with a final report as an outcome and future community resource.

The class, Historic Research and Documentation (CT 12), is part of College of the Redwoods Historic Restoration and Preservation Technology program, which seeks to equip students with the skills to assess, research, and maintain historic resources. Many of the students had taken prior courses in Introduction to Historic Preservation (CT 10), and Historic Building Analysis (CT 13) and teamed up with newer students to share prior knowledge of styles and vocabulary needed to write descriptions accurately.

The purpose of this particular project is twofold. Firstly, the class sought to improve and develop their skills in documentation of a local historic neighborhood by volunteering for this real project. Secondly, the class intends to provide the city of Arcata with a useful document to assist in any future development decisions of the Bayview Neighborhood Conservation Area (NCA). This may be also be used as a future model for continued surveys, by Arcata and other local communities.

Field notes were compiled by the students with training from Professor Bill Hole and the advice of local preservation specialists, Susie Van Kirk and Suzanne Guerra, along with prescribed state and national preservation guidelines.

Architectural elements and observations were recorded and documented in the field with the help of aerial photographs and survey maps. All of this information has been compiled and edited to its present form in Spring of 2006.

The reader of this survey will find relevant maps, photographs, and information about specific historic resources within the NCA, as well as the class objectives and methods used to acquire this information.

## Bayview Neighborhood Context

The survey area in this report is located in what was historically referred to as “stump town,” or East Arcata. Separated from the main part of town by a gulch that carried a water course, later a railroad, and today the Highway 101 freeway, this residential area was the site of the first sawmill in town. Built in the early 1850s, the Titlow Mill was located along Campbell Creek south of 11<sup>th</sup> Street and was the source of the first lumber for construction of the new town of Union, later Arcata. The area surrounding the mill was subject to early logging followed in the 1870s by commercial logging operations under the direction of James Gannon. This latter logging extended up Campbell Creek into what is now Redwood Park and the Community Forest. Logs were skidded down Campbell Creek (the skids can still be seen in the creek at the entrance to the Park via 14<sup>th</sup> street) and taken to the hilltop at Union and 7<sup>th</sup> by a pole-railed road with animal motive power and dumped into the Big Slough (Gannon or Embarcadero) for rafting to the mill in Eureka. When this logging terminated, East Arcata was a landscape of stumps, but ready for clearing and the construction of residences.

Several early houses, perhaps associated with this logging, are present in the six-block survey area. The Sobol-Rossi House at 1226 B and the Fry House at 290 12<sup>th</sup> date to the 1870s. Several 1880s houses are present: the Greenwald House, built in 1888 and remodeled in 1904, located at 380 12<sup>th</sup>; the Cates House, 185 12<sup>th</sup>, built in 1884 at the southwest corner of 11<sup>th</sup> and D at the entrance into East Arcata and moved to its present site in 1974; and the 1886 Dillon House at 388 11<sup>th</sup>, also located at the entrance into this eastern part of the town.

With the clearing of stumps and street construction in East Arcata at the turn-of-the-20<sup>th</sup>-century, a new period of building was ushered in. In 1903, the Sorenson and Ridgley houses at 1169 and 1191 C were constructed. The following year, Hume Fry, who owned the settlement-period house at the northeast corner of 12<sup>th</sup> and C, subdivided the block he owned between 11<sup>th</sup> and 12<sup>th</sup> and B and C streets, paving the way for Carl Andersen to build the Stewart and Inskip houses at 1180 and 1162 C. This block continued to develop with the Westin-Rees house at 1108 C in 1911; the Pasquini-Davis House at 215 11<sup>th</sup> in 1914; and the Walter House at 237 12<sup>th</sup> in 1908. Willie Biasca’s little shingle house at 207 12<sup>th</sup> was probably built in the 1910s to take its place among this block of early 20<sup>th</sup> century residences. A c. 1950s infill is the Stromberg House at 1144 C.

With the establishment and growth of the normal school, Humboldt State Teachers Colleges, now Humboldt State University, a new era of construction was initiated in East Arcata, notably between 12<sup>th</sup> and 14<sup>th</sup> streets and from D Street to Union. Several houses were built in the 1920s—the Lundborg House at 318 12<sup>th</sup>, Ensign House at 240 12<sup>th</sup> (a stucco), probably the house at 1289 B, the house at 340 12<sup>th</sup>, 1291 C (a stucco), and the Sven Rylander home at 1310 B. The Eagan House at 1398 B appears to be a 1920s house, built in the Preston Place Addition on the college campus and moved to its present location after WW II.



The 1930s saw construction of the Art Larson home at 1111 C and several houses on the block between C and D and 13<sup>th</sup> and 14<sup>th</sup>—the Arnold House at 320 13<sup>th</sup>, Irish House at 1357 C, Sorenson House at 362 13<sup>th</sup>, and the Clark House at 380 13<sup>th</sup>. In 1940, this block experienced major infill when mill-owner Nicodemo Lucchesi and his son James Lucchesi in collaboration with real estate broker Sam Beer contracted with “master carpenter” Charley Bloomquist to build the houses at 1399 C, 337 14<sup>th</sup>, 361 14<sup>th</sup>, and 1392 D and 1370 D streets. Two other houses were constructed in the block to the south during this same period—the Todd House at 1249 C and its next-door neighbor at 1271 C.

More houses were constructed after World War II—two stuccos at 1270 B and 1240 B and the Tuttle’s house at 1269 B (1952). The house at 255 13<sup>th</sup> was moved to its present location from the HSU campus. Other houses which have not been dated by documentation appear to date from the late 1930s, 1940s, and possibly into the early 1950s. The apartments at the corner of 13<sup>th</sup> and B and at 12<sup>th</sup> and D, and the dentist office at 12<sup>th</sup> and B probably were constructed in the 1960s.

This survey area is a subset of a much larger area known as the Bayview Neighborhood Conservation Area. This residential section of East Arcata, roughly bounded by 7<sup>th</sup> on the south, 14<sup>th</sup> to the north (a kind of unwritten boundary between town and gown), D Street on the west, and extending up to Redwood Park and the Community Forest on the east, remains remarkably intact both architecturally and historically. The hillside area of East Arcata is defined by an early 20<sup>th</sup> century settlement of people from Austria and southeastern Europe, and their houses are still identified by their first owners—Malvich, Maronich, Dubrovich, Batich, Stilich, Sobol, Rozich, Crnich, Pafso, Paskavan, and more.

The Trinity Hospital, built on the Emerson Block between B and C and 13<sup>th</sup> and 14<sup>th</sup> streets in 1943-44 with expansions in 1947 and 1948, provided health care to Arcata residents for more than thirty years. Built to replace the original hospital, destroyed by fire in 1943, the new hospital has been a commanding presence in this neighborhood. The Emerson Block was ideal because of its size, good surrounding streets, and accessibility from Highway 101 on G Street. Still owned by the Hospital Corporation, the building is presently used by the University as an annex, but may be vacated after completion of the new high-rise on campus.

The integrity of this neighborhood is maintained by the compatibility of its houses in mass, scale, and size and by how they are presented to the street and relate to each other. They are generally single-family residences, one-story or in a few cases, one-and-a-half stories. Neighborhood character is defined by modest houses generally representative of Craftsman and post-war styles. The emphasis is on human occupation not the accommodation of vehicles. Yards are rather small, but they reflect pride of ownership with planted and potted flowers and shrubs. Incompatible intrusions are minimal and the focus of residents is to maintain the strong “sense of place” that makes for quality living in this East Arcata neighborhood.

## Objectives

This report establishes a foundation for formulating planning efforts with a focus towards historic preservation within the Bayview Neighborhood Conservation Area (NCA), in Arcata California. It also forms the basis for additional review, research and documentation of historic resources in the NCA.

The enclosed reconnaissance survey developed out of the need to document structures in the NCA. A previous survey conducted in the 1970's by research specialist Susie Van Kirk, needed to be supplemented, as many buildings were never surveyed and others had undergone changes. The primary goal of the survey is to document current conditions and the unifying features of the neighborhood; these features reveal the context in which it was built: time frame, social & cultural clues, environment, etc.

Furthermore, the survey gave students the opportunity to conduct an actual survey per DPR 523 standards. The survey can assist to develop future planning guidelines that will protect the integrity and context of Arcata's neighborhoods, and may serve as a model for other communities to develop surveys of their historic resources using training programs, local volunteers and content experts.

## Survey Methodology

“A Reconnaissance Survey is an investigative field survey of structures located within an identified area. Surveys should be objective and become a useful tool for future planning” Local preservation research and survey expert Susie Van Kirk introduced the neighborhood and survey goals to students.

Bayview Neighborhood Conservation Area is adjacent to Humboldt State University includes historic Trinity Hospital which is currently used by HSU and called the University Annex. An effective field base was set up in the Chapel facility that included two computers, a printer, food, refreshments, and restroom facilities.

After an early morning briefing class on March 19, 2006, members set out in teams of two under the guidance of Professor Bill Hole and Historian Susie Van Kirk, to survey a total of eight blocks. With clipboards, field worksheet forms, informational flyers, and cameras in hand, student teams canvassed the neighborhood area. Field data was gathered during an eight hour period, of course with a sandwich run and lunchtime on the lawn included. Photos were downloaded from digital cameras into computer folders during the day.

Survey data recorded by hand in the field included definitive information of site address, Assessors Parcel Number (APN #s), owner(s) and building date when available. Other noted pertinent information consisted of physical characteristics like roof type & material, number of stories, exterior wall covering, fenestration alignment, style(s), and notable architectural features. A brief, but thorough description of the overall appearance of the house, its setting, and character defining features was also recorded on the worksheet. An actual sample survey worksheet has been provided for clarity (see appendices).

All in all, 51 historic houses and one historic hospital were surveyed, many of which had no or partial prior survey documentation.

Subsequently, ten class members took on the task of combing through the survey worksheets, digital photographs, and physical descriptions to enter them onto California State DPR 523A forms to create this report. This ended up taking much more time than anyone anticipated and enthusiasm seemed to prevail.

After students completed their work for printing the first draft, professor Hole spent more time to massage the document into an even smoother flow. This type of project can be effective if content experts are included in the process, making it an effective solution to dovetail training and local volunteer efforts into community preservation efforts.

Other research sources are enclosed and described in the Bibliography, and students on the project team who are local planners, consultants, and architect designers all pitched in with pertinent photos and documentation.

## Recommendations

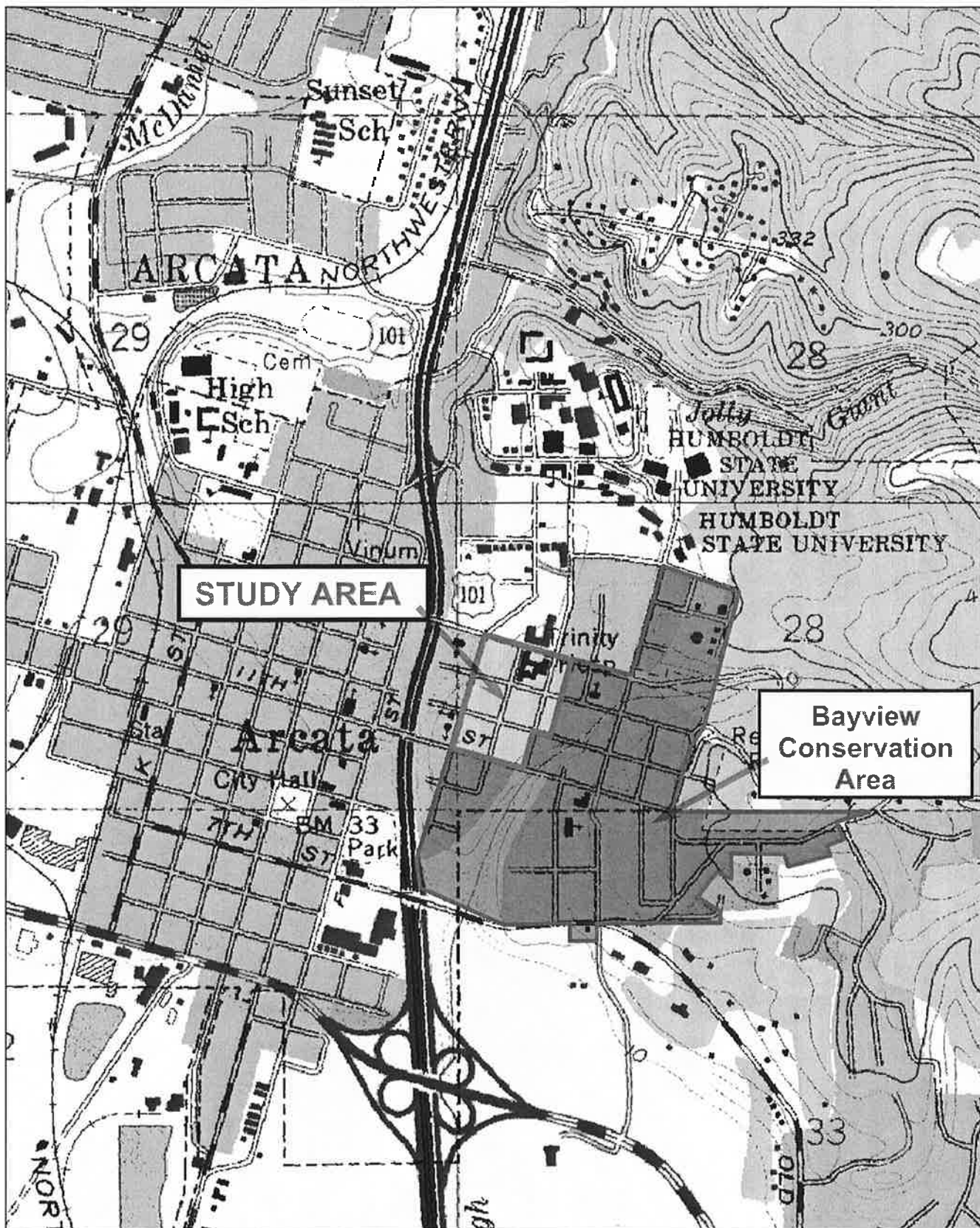
The following recommendations are offered to help future preservation efforts in the City of Arcata's Bayview Neighborhood Conservation Area (NCA).

1. Pursue documentation of the remaining 36 blocks in the Bayview NCA.
2. The City of Arcata takes leadership in location funding to complete Bayview NCA survey.
3. Develop a Historic Context Statement for the NCA.
4. Develop Design Guidelines for additions, second units, demolition and rehabilitation for the NCA to be used by the City of Arcata's Community Development Department, Planning and Design Review Commissions.
5. Consider recommendations contained within the Secretary of Interior Standards and Guidelines for all projects in the NCA.
6. Apply for Certified Local Government (CLG) status to request OHP grant funding specific to further City surveys.
7. Consider putting the Bayview NCA on the National Register of Historic Places as the "Bayview District".

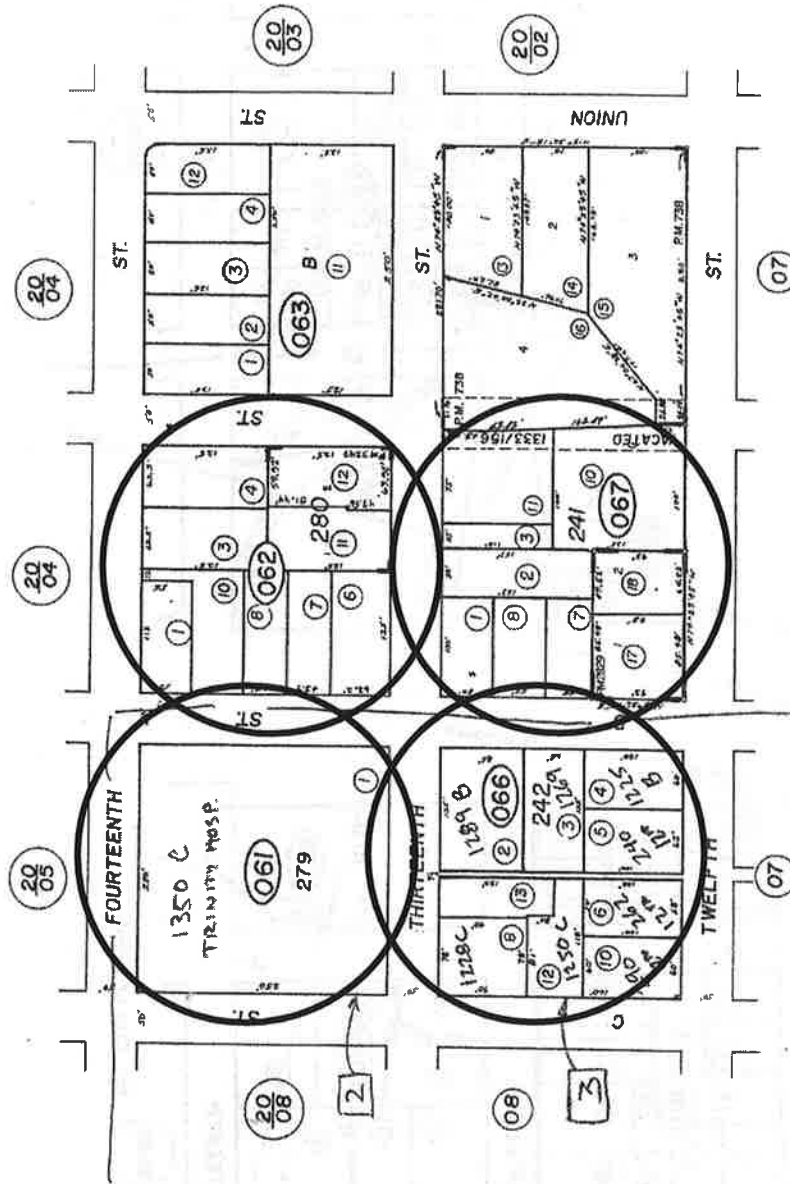
Bayview Neighborhood Survey Area

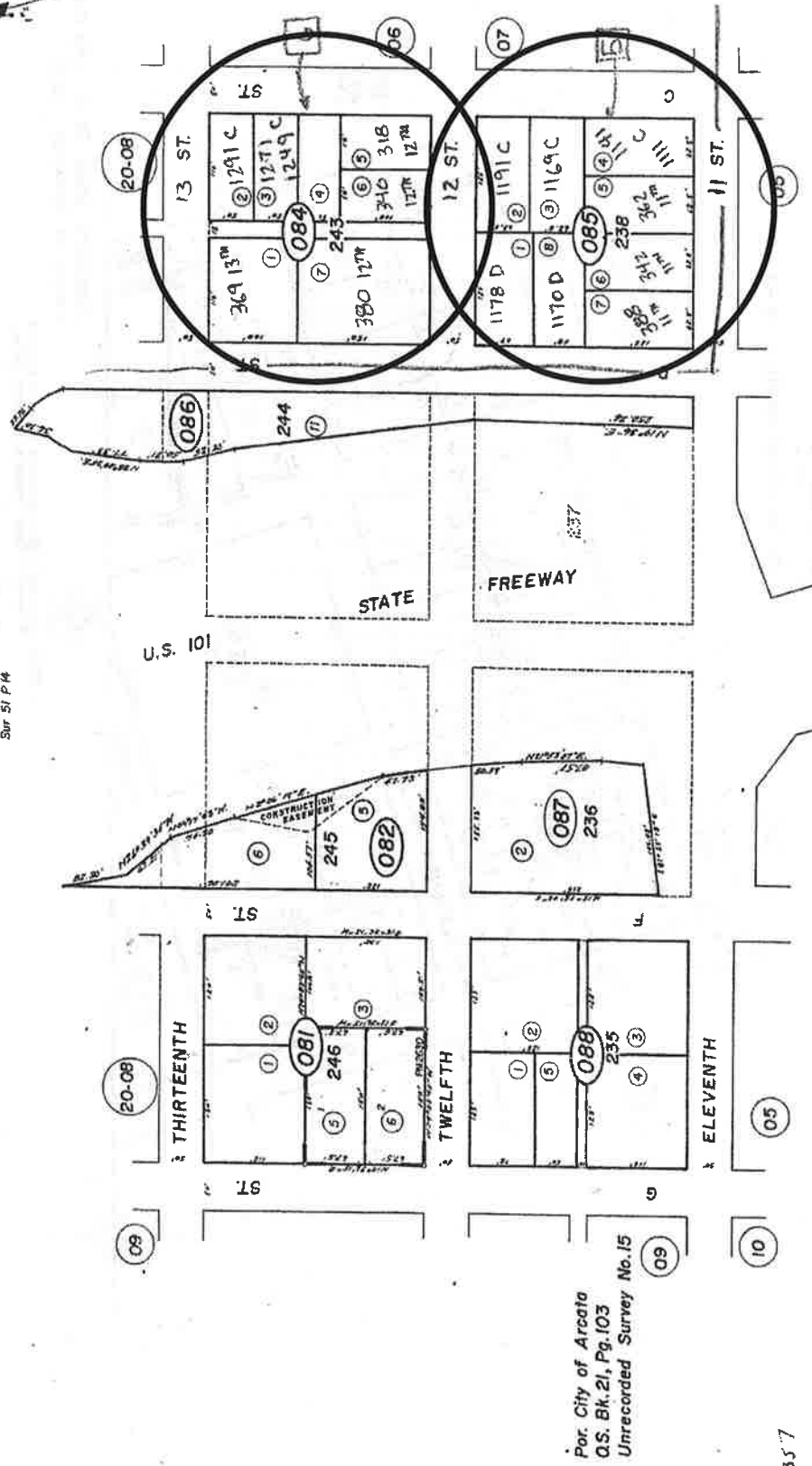

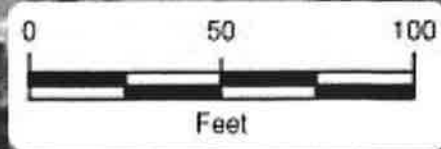

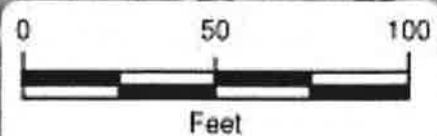

The Trinity Hospital, now the Humboldt State University Annex, was started in 1943. It is in a Mission Style, and the alcoves in the front entry, off C street speak of statues placed there by the Sisters of Orange during this building's original life. The Hospital Building had several additions and/or changes but other than those, the entire block is taken up by the Hospital complex. Being a public building it did not have a particular relationship with surrounding architecture though elements of style were found in nearby residences (particularly the rabbeted two-step lap siding). The separate buildings formed courtyards, connecting walkways and a central parking area. The vegetation in the front (west elevation) has grown over the years with a collection of rhododendrons, azaleas and camellias. These have become overgrown, covering the front windows and obstructing the style of the building. This building is an excellent candidate for rehabilitation as the building is in good physical condition and demonstrates a great potential for making its living by leasing or renting out interior spaces, rooms, etc. Additions occurred in 1947 and 1948

This minimal traditional building was apparently moved in the 1970's to allow room for the HSU Wildlife Center to be built. Today the house is rented to students. It is a single story, with two front facing, layered gables. An alley goes along the east side of the house and allows off street parking and access to a shed roofed out building. The south entrance has a small, mudroom that juts off the main building, while the front entrance on the north elevation is turned so that one enters parallel with the street via a small stair. Eave/cornice returns are the only decorative elements, besides the vertical siding in the upper gables that has a v-notch detail at the bottom. A large maple dominates the north elevation.

A Reconnaissance Survey...tips


- What usually happens during a survey?
- Start with the basics...what is in front of your face? Document what you see at hand.
- Styles are not the true measure of a building. Look at what is there.
- Look at place; how people use it; what have people done to this building through its lifetime?
- A Reconnaissance Survey is an investigative field survey of structures located within an identified area.
- A Reconnaissance Survey is to observe the built environment of a neighborhood and document things that were done before and what has been changed since.
- Record the existing context and observed past conditions. Pay attention to facts and not to conjure up stories.
- Use hand written notes that include an accurate descriptive, along with any sketches and photographs to clarify.
- Use digital camera to capture clear front view snapshot of property.
- Follow up field documentation with summarizing the findings.
- Develop further research questions, and continue to answer questions raised above.
- Finalize a report both in printed copy and on digital storage medium such as CD.

**Note:**        *This is a sanctioned College of the Redwoods class field lab*

- Be polite to any people who are inquisitive about survey business.
- Handout a project information flier and HPRT brochure per request.
- Stay on task at hand and defer in-depth questions to future visits or communication as listed on information flyer.

Survey Activity Recommendations –

**To assist in future training projects like this, the following tips for success is a list of ideas developed by class that should be considered:**

Training of volunteers – *prior training classes to teach significant information for job*

Objectives – *Need to understand objectives for effective project completion*

Architectural styles – *Important aspect of writing descriptions*

APN sheet – *Good source from assessors' office to verify property information*

Aerial Photographs – *Indispensable for accurate visual guide to assessor maps*

Clipboards, pencils, forms – *Necessary as field kit to record physical information*

Handouts – *Organize these for day of survey to use by surveyors and handout to curious onlookers*

Completion dates – *Calendar time table useful to meet deadlines with groups*

Team emails – *Important communication tool for sharing information within groups*

Meeting area – *Necessary to set up computer stations to process information over time*

Set up meeting dates and times – *Communication is important to coordinate teamwork*

Additional block documentation – *During process, holes in research requires extra work*

Digital camera – *Needed for field work to document buildings*

Computer literate – *Necessary to document and access digital records. Word, Excel, Acrobat .PDF conversion, Photoshop, digital camera storage, etc.*

Cross platform – *Considerations for software to function both on Mac and IBM platforms*

GIS experience – *May be useful for large area surveys*

Power Point experience – *Useful for presentation purposes to teach others about project*

On-line availabilities, including WI-FI – *Useful when wanting to share documents away from plug in internet access*

Printer – *Good quality color printer with plenty of ink cartridges (print all drafts in black)*

Scan – *Scanner is necessary to copy certain documents when organizing printed report*

Type style – *Includes font type, size, and appearance*

Naming files for printing and CD – *Common file names that can be stored in folders for systematic printing collation is important*

Editing DPR's – *Takes time to edit, check, and recheck accuracy and formatting prior to printing*

Brochures – *In this case, the HPRT brochures about preservation training program at College of the Redwoods*

Recommendations – *An outcome of research and documentation for future work suggestions*

Make CD – *This is a recording medium used largely today for storing digital files*

Store on thumb drive – *This is a recording medium used largely today for storing digital files*

Binders – *Purchase these to store completed report file hardcopies*

Food/beverages – *Important to volunteer maintenance and successful moral*

Budget – *needed for: computers, software, printer, scanner, storage medium, printing paper, photo paper, pens/pencils, clip boards, binders, printing costs, printer inks, paper, food/drink for survey days and subsequent documentation sessions, and hiring professional expertise when necessary, etc.*
