This activity represents the insurance premium costs for all the different coverage's. It does not include employee health. The insurance coverage's are for the City as a corporation and for officials and employees. The insurance coverage is either stipulated by law or contract. Coverages, such as medical, dental, and vision, are included in the Employee Benefit line items for the respective Activities.

ACCOMPLISHMENTS

1. Continued efforts with the Redwood Empire Municipal Insurance Fund (REMIF) to keep the City's General Liability and Worker's Compensation annual assessment premiums and deductible costs down. This particularly included REMIF Board action to contract with a TPA for both Liability and Workers Scompensation claims administration beginning May 2018.
2. Membership in REMIF continues to provide more affordable options for e;mployee safety policy development and training and superviosr/employment law training and legal resources.

GOALS:

1. Continue to work with the Redwood Empire Municipal Insurance Fund (REMIF) and other REMIF Cities to address municipal insurance needs, employee safety and risk management.
2. Work with city managers and staff from other REMIF by combining efforts too achieve economy of scale on issues of mutual concern such as employee safety and training programs.
