The Arcata City Council seeks applications to fill one vacancy on the Public Safety Committee. The Public Safety Committee, established by ORDINANCE No. 1505 became effective June 15, 2018. The Public Safety Committee (PSC) is a seven-member committee serving in an advisory capacity on matters pertaining to public safety. PSC Committee members serve three-year staggered terms, and the current vacancy will be filled by a member of the public who lives or works in the Arcata Planning Area.

The PSC holds monthly meetings or as necessary on call of the Chair. The PSC provides a forum for the City, Police, and Community members to communicate about public safety issues and concerns in the community. The PSC reviews crime trends and identifies the highest risks to public safety. The PSC studies, evaluates and makes recommendations regarding threats to public safety, crime reduction and crime prevention strategies.

Requirements for this volunteer position are as follows:

- Applicants may live within the Arcata city limits or live/work within the Arcata Planning Area. (To determine residency status, visit <https://www.cityofarcata.org/329/Vacancies-Applications>). The Committee will include five residents and two members who live/work in the Arcata Planning Area.
- Committee membership reflects interest, knowledge or experience in promoting a vibrant, safe and healthy environment in which to live, work, study and play.
