Temporary Hydrant Meter - Frequently Asked Questions



Q: How soon can I request the temporary hydrant meter?

A: We request at least a week's notice for installation. Your tank or truck will likely be inspected at the same time as installation of the meter.

Q: How do I know where a meter can be placed and what is the City of Arcata service area?

A: You may view our parcel finder map which details potential hydrant meter locations (<https://arcg.is/1iGWKb6>) & overall service area for water/sewer (<https://arcg.is/0ef9Ty0>) .

❖ *Please keep in mind that your requested location may not be feasible if already in use or in a high traffic area. We strive to pick locations that are as close to your project site as possible, but placement is at the final discretion of our water meter technician.*

Q: Can I move an existing meter that I already have rented out?

A: Yes, you can move an existing meter. Please email eservices@cityofarcata.org with your request to move the meter or if you have further questions about the process.

Q: What is the breakdown of fees that are charged for the hydrant meter?

A: First, you pay the hydrant meter deposit of **\$2,529.91** that includes the \$2,330.48 deposit and \$199.43 service fee.

After you are finished with your hydrant meter, you are then charged the daily rental fee & water consumption charges and assessed a 3% Utility Users Tax on those fees. The daily rental fee will either be \$6.17 per day if your meter rental was less than one year in duration or \$10.28 per day if the rental period exceeds a year. Water consumption fees are currently \$7.15 per 100 cubic feet.

If your deposit does not cover the fees incurred, you will be billed the remaining amount!

Q: What methods of payment do you accept?

A: We accept checks made out to the "City of Arcata", these can be attached with your application if brought in to our office or you can mail the check to our department's attention at 736 F Street, Arcata, CA 95521 and submit the application by email to eservices@cityofarcata.org.

We also accept deposit payments by credit card, and this can be done over the phone or in person at City Hall. Please email eservices@cityofarcata.org or call 707-822-8184 for more details.

Q: How do I notify the department that the meter is no longer needed?

A: You must call the Environmental Services department at 707-822-8184 or email eservices@cityofarcata.org stating that you would like to cease service. **It is the applicant's responsibility to notify the department in a timely manner to remove the meter to avoid daily rental charges if no longer in use!**
